**PRELIMINARY NOTIFICATION**

In exercise of the powers conferred by Section 5 of the Karnataka Land Revenue Act, 1964 (Karnataka act no 12 of 1964) and taking into consideration the factors specified in clauses (i) to (iv) of rule 3 of the Karnataka Land Revenue Rules 1966 such as the population, area of the village the demand under land revenue in the village and other head of account and having regard to the administrative convenience the Government of Karnataka proposes to issue a Notification to alter the limits of **Koppala** Village of Koppala Taluk, Koppal District and to constitute a new village called **Belavinala** as specified in schedule along with maps with old survey numbers and new survey numbers assigned to them.
