

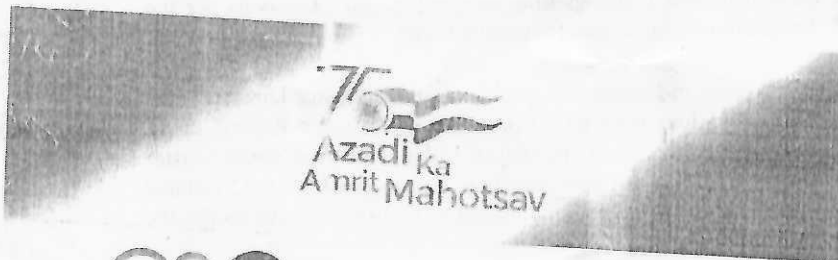

Dear Paramvir,

I am to draw your attention towards updation of jurisdictional changes and finalization of list of administrative units. As a matter of practice and in pursuance of various guidelines issued from time to time by the Office of Registrar General and Census Commissioner (ORGI), India, this Directorate is collecting information about jurisdictional changes from state government and sending the reports in prescribed format to ORGI.

ORGI Vide Census Circular No. 1 dated 22.12.2017 has instructed the Directorates to compare the Master Directory of Census 2011 with that of Local Government Directory (LGD) maintained by the Ministry of Panchayati Raj, Government of India, which is a web based application wherein all administrative units with Meta Data and Data Standard (MDDS) codes as per Census 2011 are available.

Further ORGI. Vide letter no. 9/65/2020-CD (Cen) dated 06.07.2022 has decided to introduce automation compilation of jurisdictional changes so as to generate updated list of all administrative units on real time basis through web portal. In order to ensure the correct spellings of all administrative units, it is decided to revisit the spelling adopted in old Census as per the available notifications which will be continuing in the current census frame.

As there is spelling variation / name mismatch between the Census Master Directory and LGD, this Directorate has procured notifications from the Department of Revenue Rehabilitation and Disaster Management and incorporated the correct spelling of villages in the Census Master Directory as per the notifications. However, in case of villages where notifications are not available with the Revenue Department, Deputy Commissioners are requested to certify the same as per the available record in order to maintain its uniformity and correctness.

Therefore, I shall be grateful if you could certify the list of villages provided by the Directorate and if any change is there, the same may be updated in remarks column with the supporting document, so as to enable this Directorate to finalize the jurisdictional frame for ensuing Census in a time bound manner.
