No. ADM-2-II-1971-RB-IV—In exercise of the powers of the State Government, under clauses (iv) and (v) of sub-section (1) of section 4 of the Maharashtra Land Revenue Code, 1966 (Mah. XLI of 1966), delegated to me by Government Notification, Revenue and Forests Department No. TLC-1069-32810-C (Spl.), dated the 9th November 1970, and after previous notification as required by sub-section (4) of section 4, I, D. H. Deshmukh, Commissioner of Nagpur Division, hereby direct that, with effect from the 21st day of December 1971, the local areas specified in column (1) of the schedule below which were heretofore included in the forest villages shall constitute separate village by the names respectively specified against them in column (2) of the schedule and such new villages shall constitute part of the talukas and districts, respectively, specified against them in columns (3) and (4) of the said schedule.
