
**Constitution of India.** No.KP/49 of 2023/PRHRDD/VBN/e-file/14/2023/3713/CH: - In exercise of the powers conferred by clause (g) of article 243 of the Constitution of India read with section 7 of the Gujarat Panchayats Act, 1993 (Guj.18 of 1993) and after consultation with the concerned Village Panchayats, the Taluka Panchayats and the District Panchayats, the Government of Gujarat hereby;

- (1) excludes the local area shown in column 5 from the local area of existing Village shown in column 3 of the Schedule, and after exclusion of the said local areas;
- (2) specifies the new Village shown in column 6, comprising of the local areas shown in column 7 of the said Schedule.


