Whereas, the draft Notification No. RD 123 BUDAPU 2017, Dated: 30.11.2017 regarding altering the limits of Gurmitkal and Konkall Circles of **Yadgir Taluk** of Yadgir District to constitute a new Taluk called as **Gurmitakal Taluk** was published as required by section 6 of the Karnataka Land Revenue Act, 1964 (Karnataka act No.12 of 1964) in the Karnataka Gazette No.2279 Part IV-A dated: 07.12.2017 inviting objections or suggestions from all the persons likely to be affected thereby within 30 days from the date of its publication in the Official Gazette.

And Whereas, the said Gazette was made available to the public on 07.12.2017.

And Whereas, objections and suggestions have been received and considered by the State Government;

Now, therefore, in exercise of the powers conferred by sub-section (4) of section 4 of the Karnataka Land Revenue Act, 1964 (Karnataka act No.12 of 1964) the Government of Karnataka hereby makes the following notification, namely:

SCHEDULE-I

The Villages Specified in column (3) of the table below within the Circles specified in column (2) thereof shall be excluded from the limits of Gurmitkal, Balichakra, Konkall and Saidapur Circles of **Yadgir Taluk** within the Yadgir District and constitute a new Taluk within the circle specified in column (4) thereof called as **Gurmitakal Taluk** in Yadgir District.
